Enclosed you will find the requirements and a contract for a concession booth space at the Louisiana Pirate Festival, to be held April 30-May 10, 2020, at the Lake Charles Civic Center. If you desire to have a booth on the grounds, please complete and return the enclosed contract with your deposit and proof of insurance to the Louisiana Pirate Festival office by April 1, 2020.

Please note that as we continue to make improvements to the 2020 Louisiana Pirate Festival, the festival footprint and logistics will be the same as last year. We have made a few changes to ensure that the layout will be suitable for everyone. Also, in keeping with the Louisiana Pirate Festival name, all vendors will be ***required*** this year to present a Pirate theme in their booths with Pirate-type décor, hats or costumes representing Pirates.

All contracts must be approved by the Louisiana Pirate Festival Board of Directors. If for any reason your booth is not accepted, your deposit will be returned to you immediately. Once your booth is accepted, there will be ***NO REFUNDS, NO EXCEPTIONS!***

Vendors are encouraged to promote their participation on social media and in any marketing to their customer base.

## SOUVENIR BOOTH SPACE REQUIREMENTS

- Booth space will be rented for \$10.00 per front foot with a 10 foot, minimum fee of \$100.00. This includes both weekends. If you need additional front footage it will be an additional \$7.50 per foot.
- The average depth of all booth space is 15 to 20 feet, if you require more depth for your booth, please note it on your contract.
- After set-up, each booth space will be measured to verify street frontage for any adjustments in fees:
- Contract and fees must be received by April 1, 2020
- There is an electrical fee charge of \$25 per booth, which must be paid at the time of commitment.
- No booth will be allowed to open without full payment of all fees and proof of insurance if so required.
- A picture of your booth must be provided to the LPF office along with the contract.
- If you have a tent and it is larger than a 10 x 10, there is a City Permit charge. The charge can be as much as \$40. Please contact the Louisiana Pirate Festival office for pricing.

## DATES OF OPERATION & VEHICLE ACCESS

The booths will be available to open during the Louisiana Pirate Festival operating hours:

Thursday, April 30 (4pm-10pm)  
Friday, May 1 (4pm-11:59pm)  
Saturday, May 2 (10:00am-11:59pm)  
Sunday, May 3 (11:00am-6:00pm)

Thursday, May 7 (4pm-10:00pm)  
Friday, May 8 (4pm-11:59pm)  
Saturday, May 9 (10:00M-11:59pm)  
Sunday, May 10 (11:00am-6:00pm)

### **NO VEHICLES WILL BE ALLOWED AT YOUR BOOTH SPACE DURING OPERATING HOURS.**

- Special parking and shuttle service will be provided for bringing in your products. Each souvenir vendor will be given (2) two reserved parking passes for the designated vendor parking area. Any additional parking passes needed can be purchased at the Louisiana Pirate Festival, Inc., office at a discounted price that is good for the entire festival.
- Booth vendors are NOT ALLOWED to sublease any part of their entire booth.
- Motorhomes, campers, etc. will not be allowed to park inside the festival operating area. For your camper or motorhome to be on the grounds, it must be no longer than a designated parking space provided for a vehicle. Water, electricity, or sewage will not be provided. If anyone is found to be hooked up to water, electricity, or sewage, they will be removed from the festival grounds and there will be NO REFUNDS!
- Any injury or claim at a booth must be reported to the Louisiana Pirate Festival office at the time of occurrence. Absolutely no claims will be honored after the festival closing date (Sunday, May 5, 2020).

## ELECTRICITY

- Electricity will be available to a limited extent with 110 volt/15 amp circuits for your booth.
- There will be a \$25 electrical fee per booth for basic power. Please note on your contract if you require more power and you will be advised of applicable fees.
- The City of Lake Charles requires ground fault circuit interrupters on all circuits. Please note: If your equipment is not properly grounded, electricity may not be available to you upon arrival.

## INSURANCE

- If required, Louisiana Pirate Festival, Inc., must have your Insurance Certificate by April 1, 2020, to allow time for the City of Lake Charles Risk Management Department to verify that the Insurance Certificate complies before the opening of the festival.

- The CITY OF LAKE CHARLES, SOUTHWEST LOUISIANA CONVENTION & VISITORS BUREAU, and LOUISIANA PIRATE FESTIVAL, INC., must be listed on the Insurance Certificate as ADDITIONAL INSURED(S).
- If the Insurance Certificate does not have the proper requirements of above aforementioned, THE BOOTH WILL NOT BE ALLOWED TO OPEN as per Risk Management, City of Lake Charles.

**BOOTH MERCHANDISE REGULATIONS**

- No offensive or racial items, toys that look like weapons, or drug-related merchandise can be displayed, sold, or distributed. This will be monitored during the festival, and if any objectionable merchandise appears, the vendor will be asked to remove such merchandise immediately. Failure to comply will result in immediate booth closure, and no refund will be given
- The Vendor Booth Committee will try to limit the duplicate merchandise sold; however, Louisiana Pirate Festival, Inc., does not guarantee exclusivity.
- All items to be sold, distributed, or displayed in the vendor’s booth during the festival must be listed on their contract and is subjected to approval by the Louisiana Pirate Festival, Inc., Board of Directors. Please give a detailed description of all items/merchandise.
- Each vendor is responsible for maintaining their space clean and free of trash and hazards at all times and must clean their vendor space (front, rear, and sides) when leaving each night. PLEASE remove your trash bin to the curb each night so it may be emptied.
- Vendor agrees that Vendor and Vendor’s employees, guests or invitees will adhere to all Federal, State, Parish and municipal laws and codes. Vendor acknowledges that the Vendor is solely responsible for being knowledgeable of said laws and codes. Any violation of said laws and codes will be grounds for eviction from the Louisiana Pirate Festival, Inc., grounds without notice and refund either in whole or pro-rata.
- Vendor agrees that any action or inaction on the part of Vendor, Vendor’s employees, guests, or invitees which causes or creates a hazardous, disruptive or otherwise intolerable condition, Vendor will be evicted without notice and refund either in full or pro-rata.
